Terms & Conditions Governing ReNEW Challenge

The following terms and conditions, and all subsequent revisions or amendments (“**T&Cs**”) made by the Organiser, Health Promotion Board (“**HPB**”), shall apply to the “ReNEW” Challenge. Participation in the Challenge signifies your agreement to be bound by all the T&Cs listed below. Please do not participate in the Challenge should you not agree to the T&Cs.

1. OVERVIEW OF THE ReNEW CHALLENGE

1.1 The Challenge is an initiative to encourage participants (“**Participants**”) to ReNEW Fitness, foster healthy habits and increase participation and regularity for HWE activities.

1.2 The Challenge will start on 3 January 2022 and end on 13 March 2022.

1.3 Participation in the Challenge is free.

2. PARTICIPATION ELIGIBILITY

2.1 A Participant must be a Singaporean or Permanent Resident of Singapore with a valid NRIC or a foreigner with a valid FIN.

2.2 A Participant must be 18 years or older at the point of registration.
